The Board of Directors appoints the "Non-Voting" positions and reviews their performance on an annual basis. The membership appoints the Voting positions. If you are interested in applying for any "Non-Voting" position, please submit your letter of intent to any Board Member no later than March 1st of each year.

#### QUALIFICATION POLICY OF CBOA-LONG BEACH UNIT

#### **FULL TIME MEMBER**

- Must attend a total of eighteen (18) hours in meetings, 10 hours with the Long Beach Unit. 1<sup>st</sup> year thru
   2nd year members require a total of twenty-one (21) hours in meetings.
- Must meet scrimmage requirements as directed.
- Must attain a minimum score of 80% on the Study guide and Classification Exam with the Long Beach Unit or with their home unit.
- Must pay all required fees.
- Must complete all membership and assigned forms as directed.

#### **SPLIT MEMBER**

- Must be a full-time member in another CBOA Unit.
- Must attend a total of five (5) hours in meetings with the Long Beach Unit.
- Must meet scrimmage requirements as directed.
- Must attain a minimum score of 80% on the Study guide and Classification Exam with the Long Beach Unit or with their home unit.
- Must pay all required fees.
- Must complete all membership and assigned forms as directed.
- Is not eligible to receive playoff assignments from the CBOA-Long Beach Unit.

#### **ASSOCIATE MEMBER**

- Will not receive game assignment or any instructional material.
- Will not be eligible to vote or be a member of the board of directors.
- No testing or attendance is required.

NOTE: An official who attends another CBOA Units meeting is responsible for providing proof of attendance. Verbal verifications will not be accepted.

#### **LEAVE OF ABSENCE**

Membership can request a leave of absence for the 2025-2026 season. Leave of absence must be submitted to the Secretary/Treasurer or the President.

#### EACH OFFICAL IS RESPONSIBLE FOR THEIR OWN ATTENDANCE STATUS

Officials receiving assignments prior to the start of the 2025-2026 season will have their assignments rescinded if they do not meet the following criteria:

- Continue to meet the Qualified Member requirements.
- Pay all required fees.

The Instructional Chairman and Secretary/Treasurer will inform the Assignor of the Non-Qualified officials.

These Non-Qualified officials will have their schedules rescinded and will not be allowed to officiate for the 2025-2026 season.

## 2025-2026 CIF OFFICALS FEES

The established game fees are identical for boys and girls contest for the 2024-2025 season.

A school may require you to fill out a voucher form before a check is issued and mailed to you. If you have not received a check within 14 days, make a phone call to the home team's Athletic Director. If you have not received a check or electronic payment after 21 days, call Ralph Aranda at 562 400-3428.

#### **PLAYOFF OUALIFICATIONS & PRODCEDURES**

All members are ineligible for playoff assignments during their first year of membership in the CBOA-Long Beach Unit. Officials that have previously been a member of the Long Beach Unit become eligible for playoffs assignments their second year after returning to the unit. To be eligible for playoff assignments, an official must be a Long Beach Unit FULL TIME member in good standing and must have officiated a minimum of (6) games of varsity boys or girls' games to be considered. An official who has chosen to work boys playoff games must work a minimum of six (6) boys varsity games during the season. An official who has chosen to work girls playoff games must work a minimum of six (6) girls varsity games during the season. An official who has chosen to work both boys and girls playoff games must work a minimum of six (6) boys varsity and six (6) girls varsity games during the season.

FULL TIME members that split with another Southern Section Unit shall inform the Observational Chairperson which unit they will declare for playoff assignments.

FULL TIME members who split with another Southern Section Unit shall not officiate playoff games for the Long Beach Unit that involve schools from the assigning area of the other unit. It is the ethical responsibility of the official to abide by this policy.

#### **NO-SHOW POLICY**

For a Varsity contest, an official is considered a "No-Show" when he/she arrives after the start of the game. For a Non Varsity game, an official is considered a "No-Show" when he/she arrives after the start of the 2<sup>nd</sup> quarter. He/she has lost the right to work that assignment unless the substitute official relinquishes the right back to the assigned official. The penalty for a "No-Show" is the game fee for the game they were a "No-Show." The penalty must be paid in full to the unit Secretary/Treasurer within seven calendar days of that missed assignment. If the fee is not paid within seven calendar days, the "No-Show" official will have his/her schedule pulled and will not receive any further game assignments until fee is paid. Any official having more than two "No-Shows" in the same season will be referred to the ethics committee for possible disciplinary action. The official who worked alone will receive the regular game fee from the school, plus an additional half game fee from the unit. All "No-Shows" must be reported to the President and Assignor within a 24-hour period by the offending official, the official who worked the game alone or the substitute official.

It is recommended that officials arrive at the game site at least an hour prior to the start of a varsity contest and 30 minutes prior to the start of a non-varsity contest.

#### **EJECTION PROCEDURE**


The official who ejected the player, coach, administrator, or spectator is responsible to complete the following ejection procedure. Be specific with all details in the incident report. Giving descriptive details as to what was said and what happened will play a large part in the resolution of the incident.

- You MUST Submit Ejection Misconduct Form Within 24 Hours.
- Officials failing to follow this procedure are subject to disciplinary action by the Board of Directors.
- Fill out the Ejection Misconduct Report located in the Ejection/Incident Report folder at <a href="www.cifss.org">www.cifss.org</a>
   website.

The following is a user guide summary for the ejection procedure followed by screenshots to help guide you through the process.

- 1. Sign onto www.cifss.org website
- 2. Click:

- 4. Click: Misconduct Login. Password: 123. Click Login
- 5. Click on Ejection Misconduct
- 6. Fill in the Disqualification Report: Event Information Offending Person(s) Official's Information
- 7. Fill in all required fields with as much detail as possible
- 8. Complete the report and include the following information:
  - a. Include Players/Coach's Name
  - b. Give detailed description of what occurred, who was involved, action taken, previous related warnings, verbiage used
  - c. Select reason for ejection
  - d. Include Liaison Ralph Aranda Long Beach/Whittier
- 9. Click Save.

Step 7. Click Save. This will submit the completed form to Ralph Aranda - CIF Liaison.

This is the final step and completes the Ejection Misconduct process.

Note: Ralph Aranda – CIF Liaison will send an email advising Don Fleming – President and James Yoshitake – Assignor of the incident report.

#### **POLICIES**

- It shall be the responsibility of the home management to notify the officials if there is a change to the contest date, time, or location. Whenever a contest is started and cancelled because of inclement weather, light failures, or any other circumstances beyond the control of home management, each official will receive his/her full fee.
- After an official has accepted an assignment that official can be removed only at the direction of the school's principal and by payment of the full game fee by the objecting school prior to the contest.
- When a regularly scheduled game or time is changed, and the home school fails to notify the official and he/she arrives at the site of the game the official shall receive a ½ game fee from the home school.
- Current high school students are NOT eligible to officiate CIF Southern Section contests.

Welcome back for another season. I am happy to be back to again serve you as your Assignor. I will be relying on your Arbiter Calendar Blocks to schedule your assignments. Due to this, it is of the utmost importance that you keep your Arbiter calendar up-to-date. Your Blocks are the dates and times you are not available to work. Assignments are sent to you based on this. **Help me help you get more games.** 

Members must notify me ASAP by email when they have to turn back an assignment. Text messages or phone calls will not be accepted. Assignments you accept are your responsibility until it is removed from your Arbiter schedule. Cancelling an assignment after 10:00 AM on the day of the assignment will result in a \$10 fee and possible disciplinary review by the Board of Directors. Exchanging or giving away games is prohibited and subject to disciplinary review by the Board of Directors.

A substitute official that begins working a game becomes the assigned official for that game unless that official relinquishes the game to the original assigned official. If extra official(s) arrive at a game due to an assigning error, the extra official(s) will receive ½ game fee from me.

Assignments fees remain the same as last season. They are \$5.00 for Varsity and \$4.00 for Non-Varsity assignments. Fees must be and only submitted by the three (3) requested due dates below in RED.

- Assignment fees for your initial assignments accepted must be received by November 8th. Members not submitting their fees by November 8th will have their assignments cancelled and re-distributed. These members will then only be eligible to receive turn-back games at a later date.
- Assignment fees for games accepted after November 1st must be received by January 1st. An invoice will be emailed to you on your fees balance. Members not submitting their fees by January 1st will have only those new assignments cancelled and re-distributed.
- Assignment fees for games accepted after January 1st will be due 2 weeks after the conclusion of your season. At this time, I will email you an invoice detailing all games accepted and previous fees paid with fees due or amount of refund you will be sent. Refund will be provided using the same payment method fees were received.

If a school cancels your game(s), the assignment fees for those games will be refunded. No paperwork will be required, and the refund will be automatic. Assignment fees paid for games you turn back are not refundable. Assignment fees may be paid using 1) Venmo, 2) Zelle, 3) PayPal, 4) Cash App, 5) Apple Cash, 6) Personal Check, 7) Money Order, or 8) Cash. Please do not mail cash. The Arbiter Invoice and Arbiter Invoice Receipt will no longer be used. These tools do not provide us the features that work within our requirements. Keep your cell phones handy and charged up during the season. If your Arbiter calendar says you are available, I will be texting you to ask for your availability. I encourage you to email or text me your availability. Help me help you get more games. I expect everyone to provide an explanation on why you declined an assignment. This will help me send you games you will accept.


